PRODUCT DESCRIPTION

Highly indicated for the daily maintenance of polished marbles, granites and natural stone floors. Indicated for a fast surface maintenance combining two factors, cleaning and polishing. Enhances surface colour, but also protects them from future dirt and grime. AS 22 helps minimize everyday surface scratches. Special formulated solution containing anti slip additives which reduce potential surface slipping*. Product can be used manually or with automatic floor scrubbers. Indicated for high traffic areas.

APPLICATION SURFACES

Marbles, granite, terrazzo, agglomerates and polished natural stones.

HOW TO USE

ALWAYS TEST PRODUCT FIRST following below indications, before proceeding with complete product application. Ensure that surfaces to be treated are completely dry and clean, free of dirt, dust, grime and surface incrustations. Vacuum or sweep the floor before applying product.

Small areas: Regular maintenance of floors: Dilute 30 (1 fl. oz.) ml in 1 liter (1 quart) of lukewarm water; wash with mop, cloth, wax spreader, microfibre or fleece. No need to rinse.

Large areas: ufor use with a floor scrubbing machine: Dilute 20 ml (0,67 fl. oz.) in a liter (1 quart) of water directly into the machine tank and wash the floor using soft pads.

RECOMMENDATIONS

Dilution rates are considered indicative and can vary based on material and traffic.

Non need to polish.

Before use, read completely product label, technical data sheet and safety data sheet.

(*) product reduces slipping, but does not completely stop slipping. Product is not classified an anti-slip treatment. Product has not been tested under anti slip regulations.

INDICATED COVERAGE

For protection of marble and granite polished or grinded after grid 800, with 1 liter (1 quart) of product is possible to treat 30/40 sqm (320/430 sq.ft.) In case of calcareous stone, limestone, sand stone, concrete, with 1 liter of product it is possible to treat 10/15 sqm (100/160 sq.ft.)*

(*) depending on the number of coats, texture and porosity of the surface.
